- Jenny Kidd presents violation 'findings' to the Board
- Board makes the determination how they want to proceed

- Violation?
- Warning letter?
- Fine?
- If no response from resident, Compliance committee gets involved

- Committees

  - Construction/Landscape (combined)
  - Pool
  - Social Events (funded) needs approval
  - Rules
  - Infrastructure (NEW)
- Stand alone events (non-funded) do not have to be overseen by the Board
  - TGIF (Juanita)
  - Out & About (Daisy), etc
