Two Upcoming Important Community Meetings.

February 4th at 7:00 PM Special BOD Meeting Via Zoom

By now you should have received in the mail your notice of a Special Board of Directors meeting that will be for the modification of Article 15 in our Declaration. The Declaration is the governing document that determines how we operate. Article 15 in the Declaration is about the requirement for Alteration and Improvements. Presently, it says we need 2/3 of the members to make a decision. The change reduces that to a "majority of a quorum" which is at least 50% plus one member voting yes to any proposed changes.

Marty Goss explains it like this. "The definition of a quorum is the minimum number of voting members who must be present at a properly called meeting in order to conduct business in the name of the group (the Association). A quorum of a duly convened meeting of the unit owners is 51% for doing business of the association. This should be the established minimum quorum of the membership on addressing needed changes of Association *Continued on Next Page*

Cause to Homes

In seeking to build nests, squirrels can damage homes and structures by chewing openings through the siding and underneath eaves. They also may chew through unscreened chimneys and vents and build nests in these areas. Once in this "nest," these busy <u>rodents</u> often chew on insulation and wires, which can create a fire risk. Additionally, when squirrels run along utility power wires and cables, they can short out the transformers.

Squirrel Damage in the Garden

Like <u>rabbits</u>, squirrels can cause severe damage to landscaping and plants in several ways. They like to dig in lawns for nuts and to chew on the bark and twigs of trees and shrubbery. They also dig for planted bulbs. But worst of all, squirrels have voracious appetites and can quickly decimate the crop of a vegetable garden or fruit tree. Like humans, they often wait until the fruits or vegetables are ripe enough to eat, which makes the loss of the crop even more heartbreaking for the gardener.

BEYOND THE BOX:

Sweet & Spicy Mac . . .

Toss 1 diced small, sweet potato and 1 chopped apple with 2 Tablespoons of olive oil and ¼ tsp. each cinnamon and cumin.

Roast at 400 degrees until tender and browned, about 15 minutes. Stir into a prepared box of Mac & Cheese along with 1 cup rinsed canned black beans.

Spicy Baked Mac . . .

Mix ¼ tsp. each cayenne and paprika and your favorite hot sauce to taste into a prepared box of Mac & Cheese, spoon into a baking dish. Top with ¾ cup panko breadcrumbs and ¼ cup grated parmesan cheese. Bake at 350 degrees until browned, 5-8 minutes.

Green Mac & Cheese . . .

Saute 1 clove chopped garlic, 2 cups each broccoli florets and chopped kale and 1 cup chopped baby spinach in 2 Tablespoons of olive oil until softened. Stir into a prepared box of Mac & Cheese and season with pepper.

property that are required to be voted on by the members. When you multiply 51% times 219 equals 111.69 rounded to 112. This would establish that if 112 votes were not received then the addendum change would not pass. When and if 112 votes or more were received a majority of the votes would determine if the Addendum would pass or fail.

It is a waste of time and money to propose changing even the color of the club house walls if it requires 2/3 votes. The purpose of changing the Declaration is to keep the quality of the Associations property at the best possible condition for all members of the association to enjoy. It is not the intent of this board to remodel the clubhouse, but only keep things up to date as voted on by the unit owners."
