Message from the Board:

Last month the board unanimously voted in Standards and Specifications for our roofs. This was a recommendation from our lawyer. You can find them under the documents tab on our community website.

#### www.springwoodvilla2.org

This will allow the residents options when replacing their roof. We would like to have the community vote on making them part of our By-Laws.

This will take 66% of all voting parcels in our community which means we will need 146 of the residents to vote in favor of the change. Historically we have had to go door to door to get the votes needed to make a change to our documents. We would like to first send out a community vote to lower the percentage to 54% of the voting parcels which means we will need 119 votes to make a change to our documents. If we can make this happen, we will then send out another vote to incorporate the Standards and Specifications into our By-Laws. Once this is accomplished it will take a community vote to make any changes to the Standards and Specifications. This will also aid in getting our documents more current with today's laws.

Currently the Standards and Specifications can be changed by a majority vote of the board.

Over the past few years, the cost of replacing a white barrel tile roof has almost doubled in price. By making the Standards and Specifications part of our documents, residents will be able to have choices on the material used to replace their roof saving them their hard-earned money.

We encourage all residents to take the time and vote on both issues when they receive the mailings and any future mailing requesting a community vote.

## To my Neighbors:

An article with this title was printed in the June 2024 issue of The Springboard.

The main point, I understood, was one of being neighborly during this period of drought in Pinellas County. While views may differ on the '(un)neighborly spirit in filing complaints, against neighbors, I wish to address those in our community who continue to violate the water conservation rules. You are the ones who are not being neighborly as clearly you do not care about the greater good!

The Southwest Florida Water Management District continues its designation of our area as experiencing a water shortage. Pinellas County Utilities is enforcing a restriction of watering our lawns and plants to one day a week. You can easily find the details on the website pinellas.gov. It is clearly stated that you cannot "hand water a lawn on a restricted day or more than once a week". There is no excuse for thinking hand watering is okay.

If you ignore the water restriction rules you are subject to fines and rightfully so! If the drought conditions worsen (because you ignored the rules) and a Phase 2 order is issued, any offence will receive a fine of \$193. No warnings will be issued.

I care about my lawn and my plants. I am distressed that the lawn has turned brown, and my plants are drooping. But I care more about the impact of water shortages on the whole community of Pinellas County. I will do my part following the rules, for the sake of all my neighbors! That is being neighborly.

#### Change vs. No Change:

The last time there was a community referendum to update our documents approximately 145 owners responded either in person or by proxy, the other one-third of owners didn't think it was important enough to submit their proxy.

Approximately 106 of the 145 were affirmative votes, that was about two-thirds of the total owners who responded either by proxy or in person. The referendum didn't pass because 146 affirmative votes (two-thirds of the entire membership) is needed to pass.

Our documents were written over 50 years ago, a lot has changed since then, especially Condominium Law. The newly formed Documents Committee along with the Board of Directors, and with the guidance of our Association Attorney will be able to rewrite our documents so that it can be current and align with Florida Statue 718.

Being on the board for almost 10 years and knowing first-hand the difficulty of getting two thirds of the community to participate in any kind of referendum was almost impossible to achieve. When was the last time we held an Annual Membership Meeting where there was a quorum? Would you believe it's been more than a decade?

Our **Declaration of Condominium** requires affirmative votes of two-thirds of the membership to make changes to sections within the Declaration itself. This includes simple things like changing the color of the interior or exterior wall of the clubhouse, or any material change that is different from what is presently there. In some instances, guidelines are unclear, nonspecific and could be construed differently from what they were intended to be.

On the other hand, our **Articles of Incorporation** state that affirmative votes of two-thirds of owners present or by proxy are needed to make changes to the articles of incorporation.

This, in my opinion makes more sense. Why do we allow owners who are complacent, affect those of us who are not. Just doesn't seem right.
